However, during the year, the members of the Company at their Annual General Meeting held on September 21, 2020 by way of special resolution under section 197 of the Act, waived off the recovery of excess remuneration of Rs. 68, 12,300/- paid to Mrs. Savita Gupta, Whole-time Director of the Company, during the financial year 2019-20.

13. Appointment/ reappointment/ filling up casual vacancies of Auditors areas per the provisions of section 139 of the Act.

14. During the year under review, there was no instance requiring approvals of the Central Government, Tribunal, Regional Director, Registrar, Court or such other authorities under the various provisions of the Act;

15. During the period under review, the Company has not accepted/renewed/repaid deposits.

16. During the year the Company has obtained secured borrowings from Banks and Financial Institutions for which creation /modification /satisfaction of charges has complied in that respect, wherever applicable.


